THIS IS THE ONLY WARRANTY THAT APPLIES TO THE HARVEST KING TIRES PURCHASED BY YOU AND SUPERSEDES AND REPLACES THE TERMS OF ANY PREVIOUS WARRANTY. NOTHING IN THIS LIMITED WARRANTY IS INTENDED TO BE A REPRESENTATION THAT TIRE FAILURES CANNOT OCCUR. TBC BRANDS NEITHER ASSUMES NOR EXTENDS, NOR AUTHORIZES ANY OTHER PERSON OR ENTITY TO ASSUME OR EXTEND ON ITS BEHALF, ANY OTHER OR DIFFERENT WARRANTY OBLIGATION.

ORIGINAL PURCHASER'S OBLIGATIONS

To make a claim under this Limited Harvest King Warranty, you must be the original purchaser, and you must present the warranted tire to an authorized Harvest King tire dealer for adjustment along with the following items: proof of purchase showing that you purchased tire, the date of purchase and installation, and the vehicle on which the tire was originally installed. Your original invoice when you purchase the tire should contain this information. You are responsible for payment for any extra products, services or upgrades that you request that are not covered by the limited warranty or warranty allowances.

IMPORTANT SAFETY INFORMATION

Any tire, no matter how well constructed, may fail due to improper installation, maintenance or service, creating the risk of property damage and/or serious or fatal injury. For your safety, comply with the following:

- ONLY PROFESSIONALLY TRAINED PERSONNEL SHOULD MOUNT TIRES.
- Property damage and serious or fatal injury can also result from improper tire mounting and inflation procedures which can cause the tire beads to break with explosive force during installation of the tire on the wheel rim. This can also occur when the tire size is not properly matched to the wheel's rim. Serious injury or damage can also occur if the wheel rim and tire bead are not properly lubricated prior to installation or if maximum tire pressure is exceeded when seating the tire bead on the rim.
- Never operate an agricultural tire at speeds, on surfaces or in conditions that are not suitable for agricultural vehicles.
- Never operate a vehicle with tires that have less than 2/32nds of an inch of tread remaining; replace tires as soon as the tread reaches the treadwear indicators molded into the tread grooves of the tire which reveal when the tread depth remaining is 2/32nds of an inch.
- Proper tire inflation is essential. Under-inflation produces flexing of sidewalls and builds up heat to the

point that premature tire failure may occur. Over-inflation can cause the tire to be more susceptible to impact damage, but Do Not reduce pressure when tires are hot.

- Check air pressure at least monthly when tires are "cold" - a "cold" tire is one which has been stationary for a minimum of 2 hours or driven less than 2 miles. Use an accurate tire air pressure gauge.
- Never overload the tires. The maximum load capacity and maximum inflation pressure are molded into the sidewall of your tire. Overloading a tire will result in the build up of excessive heat which can lead to early tire failure. Overloading a tire will render a tire ineligible for warranty.
- Avoid damaging objects which may cause internal tire damage. Continued use of a tire that has suffered internal damage (which may not be visible externally) can lead to serious/dangerous tire failure.
- Inspection and the determination of the internal damage to a tire requires dismounting of the tire from the wheel and examination - all of which should be done only by a tire professional.
- Excessive speeds create heat buildup in a tire, leading to possible tire failure. "Excessive speed" is a speed that does not take into consideration the weight of the load/and or the condition of the road you are traveling on. Never travel above the legal posted limit, and slow down accordingly to a proper speed.
- Properly load and distribute the weight of the load in your trailer. Improper weight distribution can have adverse affects on the safety of the trailer and the performance of the tires.

ADJUSTMENT PROCEDURE

Please call TBC Brands warranty toll-free number at: 1-800-238-6469. Please be prepared to provide proof of purchase of the product and purchase date. Our Product Warranty Specialist will confirm the coverage of the Harvest King limited warranty and discuss your tire issue with you. They will find a Harvest King dealer nearest to you whom you may take your Harvest King tire to for inspection and any applicable warranty adjustment. TBC Brands will work with the tire dealer to supply a replacement Harvest King tire or comparable tire in an efficient manner.

The authorized dealer has no authority or responsibility to make the determination as to eligibility for coverage under the warranty.

Applies To Tires Purchased On Or After July 1, 2009

ELIGIBILITY

You are eligible for the benefits of this Limited Warranty if you are the original owner of a new Harvest King®-branded agricultural tire, this tire has been continuously installed on the agricultural vehicle on which it was originally installed and no warranty exclusion or exception applies. This limited warranty does not apply if the Harvest King tires are installed on a vehicle that is used outside the United States or Canada. This limited warranty does not cover tires marked as non-adjustable (i.e., "NO ADJ" or "NA").

This limited warranty provides two separate benefits: a Defect Limited Warranty for defects in material and workmanship, and a Field Hazard and Stubble Damage Limited Warranty. Each such limited warranty provides different coverage and benefits. Only one of these warranties will be applicable to any tire presented and will provide warranty coverage, replacement and adjustment. Proof of purchase of the Harvest King tire is required to obtain the coverage and benefits of these limited warranties.

TIRE DEFECT LIMITED WARRANTY - WHAT IS WARRANTED AND LENGTH OF WARRANTY?

Your Harvest King agricultural tire is warranted against failures due to defects in workmanship and materials and is eligible for warranty replacement and adjustment for such defects if presented for replacement and adjustment within sixty (60) months from the date of installation and there is a minimum of 3/32nds of an inch of tread depth remaining on the tire presented. Once the warranty period or useable tread of a Harvest King tire has been exhausted, the coverage and benefits of this limited warranty for defects in material and workmanship terminates and the benefits are no longer applicable. Your Harvest King tire will be replaced with a new Harvest King tire or comparable tire marketed by TBC Brands without charge for the tire and mounting

if the tire fails due to a defect in workmanship or materials during the first twelve (12) months following installation, and if no more than ten percent (10%) of the original tread depth has been used when presented. However, if your tire fails due to a defect in workmanship or materials after the applicable no-charge replacement period or the tread use exceeds that allowed, you will be entitled to a prorated allowance applicable to the purchase price of a comparable new Harvest King tire or other comparable tire brand marketed by TBC Brands. Your replacement tire allowance will be prorated based on the date of manufacture and the amount of tire use after it was installed. This use is calculated by determining the percentage of original useable tread depth on the new Harvest King tire installed on your vehicle that has been used when the tire is presented for replacement and adjustment. You will also be responsible for the cost of mounting the replacement tire and the taxes applicable to the prorated amount as well as for that if any other services you require at that time. The adjustment schedule for tires after twelve months of service or more than ten percent of tread use is as follows:

Tire Installed	Original Tread Depth Used	Adjustment Allowance
Less than 24 months	No more than 20%	75%
Less than 36 months	No more than 40%	50%
Less than 48 months	No more than 60%	30%
Less than 60 months	No more than 80%	10%

The price of the warranty replacement tire is determined by multiplying the cost of the new replacement tire by the Adjustment Allowance percentage. The result is the price of the new replacement tire.

DEFINITION OF A COMPARABLE TIRE

A new “comparable” tire will be supplied under this warranty if a matching new Harvest King tire is out of production or is unavailable when the original tire is presented for warranty replacement. In this case, a warranty replacement tire may be substituted that will be of equal price, quality and construction and a suitable match to the other tires installed on your vehicle. A comparable tire may, however, have a different sidewall or tread configuration. If the purchaser requests a higher-priced replacement tire instead, the purchaser must pay the price difference for the “upgrade” after the appropriate prorated allowance for a comparable tire has been deducted.

COMPUTING TREAD DEPTH

The amount of the original useable tread depth of each new Harvest King tire varies and depends on its type and size. The Purchaser will be informed by the Harvest King dealer of the original tread depth of the tire purchased when presented for warranty replacement and adjustment. The original tread depth does not include the last 2/32nd inch of tread depth because it is not usable for safety reasons and is deducted to determine tread use. Because tires do not

always wear evenly, tread depth may vary depending where on the tire’s tread the depth is measured. The lowest depth on the tire is used to determine the amount of original tread used for purposes of warranty replacement and adjustment.

LIMITED DEFECT WARRANTY EXCLUSIONS AND LIMITATIONS

This section should be read carefully because it may determine whether you are entitled to a warranty replacement or adjustment allowance. The limited warranty against defects in material and workmanship provided herein do not apply if one or more of the exclusions and limitations set forth above or in this section below are applicable. Your limited warranty protection from defects in material and workmanship do not apply if:

- tire failure was caused by field or road hazards, or stubble damage
- tire was transferred to another vehicle after it was originally installed
- tire is branded as “Blemish” or the molded DOT number has been removed or disfigured
- tire was repaired only with a self-vulcanizing plug, improper section repairs or in a manner that does not comply with Rubber Manufacturers Association standards
- vandalism, theft, long-term improper storage or other abuse applies
- improper mounting procedures, mismatching of adjacent tires, rim slip, or misapplications apply
- over- and under- inflation, overloading or failure to maintain proper tire pressure applies
- addition of liquids, solids or gases (other than air, nitrogen, carbon dioxide) such as sealers, balancing materials or fillers apply
- mechanical failures of the vehicle on which the tire is installed apply
- the wheel on which the tire is mounted is defective or fails

FIELD HAZARD & STUBBLE DAMAGE LIMITED WARRANTY

If your new Harvest King agricultural tire becomes unusable or not repairable during normal agricultural service due to “field hazards” or “stubble damage”, it is covered by this Field Hazard & Stubble Damage Limited Warranty. This limited warranty provides an adjustment allowance only. You will receive the adjustment allowance set forth below applicable to the purchase price of a new comparable Harvest King or equivalent replacement tire. You must also pay the cost of mounting the replacement tire and applicable taxes as well for any other services you require.

Less than 12 Months	Less than 25%	50%
Up to 24 Months	Less than 50%	25%

The price of the warranty replacement tire is determined

by multiplying the cost of the new replacement tire by the Adjustment Allowance percentage. The result is the price of the new replacement tire.

The “field hazards” and “stubble damage” covered by this limited warranty are the fabric breaks, cuts, snags, punctures, tears in tire tread, bar or shoulder which occur when a tire designed for agricultural use comes in contact with the ground hazards and elements normally found in agricultural planting fields and the agricultural plant stubble that is present when agricultural crops have been planted and are present until tilled under. To avoid damage to tires from field hazards and stubble, you should ensure that tires run between planted rows and not on the stubble and that tilling occurs first parallel to the planting rows. Hazards outside those normally associated with normal agricultural use are not covered by this limited warranty, e.g., earth moving or land-leveling, pulling contests, etc.

LIMITED FIELD HAZARD AND STUBBLE DAMAGE WARRANTY EXCLUSIONS AND LIMITATIONS

- Tire was transferred to another vehicle after it was originally installed
- Tire is branded as “Blemish” or the molded DOT number has been removed or disfigured
- Tire was repaired only with a self-vulcanizing plug, improper section repairs or in a manner that does not comply with Rubber Manufacturers Association standards
- Vandalism, theft, long-term improper storage or other abuse applies
- Improper mounting or de-mounting procedures, rim slip, mismatching of adjacent tires, or misapplications apply
- Over- and under- inflation, overloading or failure to maintain proper tire pressure applies
- Addition of liquids, solids or gases (other than air, nitrogen, carbon dioxide) such as sealers, balancing materials or fillers apply
- Mechanical failures of the vehicle on which the tire is installed applies
- The wheel on which the tire is mounted is defective or fails

NOTE: THIS WARRANTY GIVES YOU SPECIFIC RIGHTS, WHICH VARY FROM STATE TO STATE. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGE OR HOW LONG AN IMPLIED WARRANTY MAY LAST, SO CERTAIN LIMITATIONS OR EXCLUSIONS HEREIN MAY NOT APPLY TO YOU. HOWEVER, TO THE EXTENT PERMITTED BY THE LAWS OF YOUR STATE, TBC BRANDS DISCLAIMS ALL WARRANTIES EXPRESS OR IMPLIED OTHER THAN THE WARRANTIES STATED IN THIS LIMITED WARRANTY, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. ANY IMPLIED WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR OTHERWISE IS LIMITED IN DURATION
